Natural resource development in resource fragile rain fed areas to improve the livelihood status. Skill development and to initiate various socio economic educational, health, entre-partnership development, women empowerment, trainings and micro credit management with the active participation of community based organizations through participatory approach.

Mission Statement

Impact of the Project Implementation:

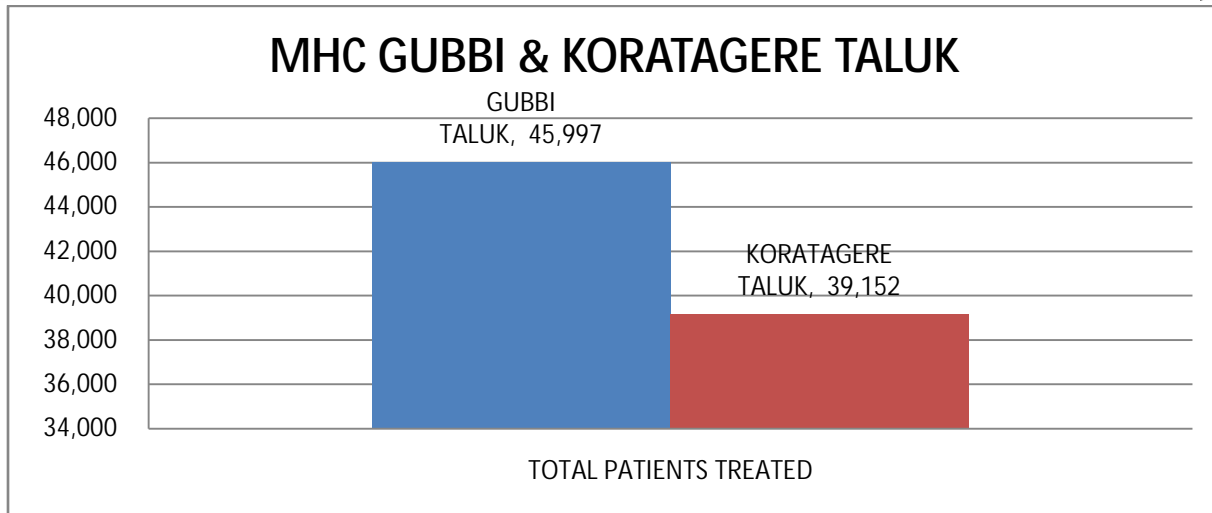
Upon the implementation of the Watershed project in the three MICRO Watershed Area , The Following are the Given Significant Improvement Found.

- Impact on increase in ground water Table .
- Increase in Agricultural Production
- Change in the Agricultural Technology Adoption
- Availability of Fodder is Multiplied & increase in Live Stock Population
- Significant improvement in re generation of Forestry as well the Horticultural Plantations
- Changes in the Attitude & Behavioral in the Rural community & could able to reach mobilize the social communities.
- Mobilization of the credit from the various Institutions for utilization of Agricultural & Non Agricultural Usage
- Impacted on Convergence of various departmental programmes for further improvement in the land based as well skill based projects
- The Rural community has strived towards sustainability of the executed project through Mobilizing the Government & Other Sources of applications

MOBILE HEALTH CLINIC PROGRAMME :

The main objective of the project is to provide primary health care services at village level using mobile health clinics on weekly basis. The mobile health unit includes one doctor, two staff nurses, one pharmacist and one Attendant. Ten villages were selected by the Department for this purpose in each taluk with 5 working days and a half – day visit to each village weekly has been scheduled. All together 20 villages have been taken care by 2 project area. Over 39152 and 45997 patients were treated in Koratagere and Gubbi taluks respectively.

The total of 85,149 patients treated from the Mobile Health Clinics of which 39,152 patients treated from Koratagere taluk and 45,997 patients treated from Gubbi taluk.



The major illness and treatment given under this project is as follows:

- **Fever cases:** Total of 12,204 fever cases were treated in both the taluks of which 6,069 cases treated from Koratagere taluk and 6,135 cases treated from Gubbi taluk.
- **Gastric cases:** Nearly 10,320 gastric cases treated under both the taluk. 4,975 cases treated from Koratagere taluk and 5,345 cases treated from Gubbi taluk.
- **Respiratory infection:** Respiratory infection is another main health problem that we identified from the project area. Nearly 10,879 cases treated from both taluk of which 5,559 cases treated from Koratagere taluk and 5,320 cases treated from Gubbi taluk.
- **Chronic Arthritis:** Chronic Arthritis is another major health problem in the project area. 11,673 total Chronic Arthritis cases were treated from both the project area. Nearly 6,512 cases treated from Koratagere taluk and 5,161 cases treated from Gubbi taluk.
- **Anaemia:** Anaemia is found as a major health threat to the rural population in the project area. We found and treated nearly 2,617 cases in both taluks. 768 cases treated from Koratagere taluk and 1,849 cases treated from Gubbi taluk.
- **Worm infestation:** Worm infestation is another leading problem which contributes Anaemia cases that we found as a major health threat to the project area. We nearly treated 2,919 cases in the project area. 481 cases treated from Koratagere and 2,438 cases treated from Gubbi taluk.
- **Skin Diseases:** Skin diseases are another health problem we identified and treated. Nearly 3,920 skin diseases treated in both the taluks of which 1,702 cases from Koratagere taluk and 2,218 cases treated from Gubbi taluk.
- **Eye and Ear infection/ Discharge:** The other major health problem we identified is eye and ear problems. We have treated 653 eye discharge cases and 805 ear discharge cases in Gubbi and Koratagere taluk.
- **Dental and Gum infection:** Totally 1469 cases are treated out of which 464 cases are from Koratagere & 1005 cases are from Gubbi Taluk
- **Pelvic Infection:** The other major health problem we treated is pelvic infection. Nearly 1,096 cases treated from both taluks of which 878 cases from koratagere and 218 cases from Gubbi taluk.

CASE STUDY OF PULMONARY TUBERCULOSIS

Mr. Subba Rao a male patient aged about 65 Years hails from a poor family lives in Ranojipalya a remote village situated about 30 Km away from Koratagere town . He lives with 2 children & wife.

The Mobile Health Clinic of Koratagere visits this village every Saturday. Mr. Subba Rao visiting this MOBILE HEALTH CLINIC (MHC) since 1/12/2013. His major complaints were recurrent fever, cough & loss of appetite. With symptomatic treatment he was getting relief and symptoms used to appear again. He was a chronic smoker.

Over a period of about four weeks, on examination he had lost weight and became anemic also. His weight was 42 Kgs , HB% was 9 Gms,. At last we took him to Holavanahalli Primary Health Center, where sputum for AFB was done and it was sputum positive. His ESR was also quite High. Chest X Ray revealed the presence of tuberculosis. He was diagnosed to have pulmonary tuberculosis and put on RNTCP (Revised National Tuberculosis control Programme) treatment for Six months by Holavanahalli PHC.

As soon as the category - 1 anti tubercular drugs started, his Acid Peptic Disease complaints increased. He complained of severe epigastric discomfort, vomiting etc. He refused to continue the treatment. During our weekly visits we used to meet him regularly & sometimes we visited his house also. We treated his Anemia, gastric problem and improved his general condition. We motivated him every week and made him to take the Anti tubercular drugs regularly. He left Smoking completely.



At frequent intervals we used to subject him for repeated Chest X Ray, Sputum examination for AFB to know the improvement rather the disease prognosis. He recovered and responded to the treatment of our MOBILE HEALTH CLINIC (MHC) as well to PHC Holavanahalli. His weight is now increased to 46 kgs from 42 Kgs. His sputum for AFB became negative. He recovered completely

Now Mr. Subbarao is leading a normal Life & we the MHC Koratagere team are very happy to see the re- appearance of smile on his face.

ASSIGNMENT FOR INFORMATION, EDUCATION AND COMMUNICATION (IEC) UNDER INTEGRATED HOUSING AND SLUM DEVELOPMENT PROGRAMME (IHSDP) OF CENTRAL GOVERNMENT SPONSORED JNNURM SCHEMES:

Background of the Project

The Jawaharlal Nehru National Urban Renewal Mission (JNNURM) is the single largest initiative ever launched by the Government of India to address the problems of infrastructure and basic services to the poor in cities and towns in a holistic manner. It envisages reform-driven, fast-track and planned development of cities, with focus on efficiency in urban infrastructure/service delivery mechanism, community participation and accountability of Urban Local Bodies (ULBs) towards citizens. The Mission is to be implemented over a period of 7 years (2005-2012) with Central Assistance to States. Elected ULBs are to play a vital role in the implementation of JNNURM. Capacity building of local bodies and agencies connected with the provision of urban infrastructure, housing and civic amenities and services are critical to the success of JNNURM

Overall Objectives of the Project

- Modern and transparent budgeting, accounting, financial management systems, designed and adopted for all urban services and governance functions;
- City-wide framework for planning and governance will be established and become operational;
- All urban poor people will have access to a basic level of urban services;
- Financially self-sustaining agencies for urban governance and service delivery will be established, through reforms to major revenue instruments;
- Local services and governance will be conducted in a manner that is transparent and accountable to citizens;
- E-Governance applications will be introduced in core functions of ULBs resulting in reduced cost and time of service delivery processes.

Objectives of the programme:

- Ø To improve the quality of life of slum residents,
- Ø To increase the standard of Health, Education and Community life in the slums,
- Ø To provide sustainable improvements in the standards of Living, Social Status, Health, Education etc.
- Ø To provide skill up gradation / increase potential income of people living in slums and
- Ø To take up Health promotional programmes like MCH, FW and Nutritional programmes and to promote Family Planning.
- Ø To reduce gender disparity, drug addiction etc.

Scope of the Assignment

- Ø To formulate IEC strategy
- Ø To develop media plan
- Ø To workout the communication strategy
- Ø To evolve action plan (implementation Plan)
- Ø To design, produce and supply IEC materials to KSDB
- Ø To implement the IEC action plan in the slums in 22 IHSDP towns across the state
- Ø To develop and utilize CBOs for counseling and Education purposes
- Ø To initiate income generation activities through governmental and Non-governmental services
- Ø To formulate and utilize neighborhood committees
- Ø To identify and arrange for short training programmes for wage earning
- Ø Counseling for transformation slums into
 - Place for live
 - Place for work
 - Place for spell

It is proposed to develop strategy which suits the regions in which the activities are to be carried out based on the requirement of the region. The Board has 5 different regions to implement IHSDP- IEC strategy project which are broadly as follows:



Region -1: KANAKAPURA, CHINTAMANI, SIDLAGHATTA, GOURIBIDNUR AND MANDYA (05 TOWNS)

Region - 2: BELGAUM, HUBLI PHASE 1,2,3. GADAG-BETAGERI AND BAGALKOT (06 TOWNS)

Region -3 : CHINCHOLI, GULBARGA, SHAHPURA, BHALKI and KOPPAL (05 TOWNS)

Region -4: PAVAGADA, HIRIYUR and SIRA (03 TOWNS)

Region - 5: SHIMOGA, SHIKARIPURA and KADUR (03 TOWNS)

MICRO FINANCE PROGRAMME – (ABHIVRUDDI As Business Correspondent):

Micro finance programme is a very good approach to reach the interior villages and provide banking services to the rural community and self help groups. It improves the socio economic conditions of the rural poor and relieves them from the clutches of the local money lenders. Due to easy access of financial assistance, rural people could start livelihood activities based on the availability of local resources.

Abhirudhi has initiated this activity in 56 villages of Gubbi taluk, Tumkur district and 70 villages in C.R.Patna and Arasikere talukas of Hassan district. The rural poor had a tough time in getting the loans from the banks and hence emerged the concept of Micro Finance through a private institutions, which worked more like a bank with a bit more interest charged than the bank (but much lesser than the money lenders). The very concept of curtailing the money lenders from the rural populace through formation of SHGs was a laudable one throughout the country.

ABHIVRUDDI helps people out of poverty through NABFINSs Direct Lending. Which contain basic financial services - including small loans, savings accounts and insurance? Alongside non-financial services such as business training through training institutes. ABHIVRUDDI assists people living in poverty who wouldn't usually qualify for regular banking services because they lack awareness, formal identification and a hand holding service.

LOAN CONSUMPTION BY THE SELF HELP GROUPS!

Apart from the regular internal consumption purposes, **ABHIVRUDDI** strategy is also to provide a comprehensive set of livelihood promotion services which include Agricultural / Business Development Services and Institutional Development Services to rural poor households under one umbrella.

The collective portfolio of these groups for financial services is large and the types of services they demand vary across households and micro-enterprises and over time. The loan amount within < 2 lakhs will be mainly utilized for their internal purpose and the loan amount above > 2 lakhs have been used for the economic activities.



Loans as small amount of *Rs. 2,500 – 3,000 / member help people in poverty start or grow their own small business.* This enables them to earn an income so they can afford food, clean water, proper shelter and an education for their children.

The goal of ABHIVRUDDI is to create income and employment in poor communities through the development of local micro-enterprises and, in the process, increase the financial well-being of borrowers, their families, and the community at large. Assisting people with micro-credit will lead to the creation of new income in local communities.

THE SUCCESS

The project was sponsored by NABARD Financial Services (NABFINS), Tumkur and Hassan. The outstanding Principle as of March 2014 is Rs. 17.89 crores from 612 SHGs in Hassan, & Rs. 9.13 crores from 376 SHGs in Tumkur District. In Hassan Rs 39.05 crore loan has been released to 973 SHGs and in Tumkur, Rs, 21.65 crore loan has been released to 605 SHGs. Recovery rate is nearly 100%

HABITAT SANITARY PROGRAMME :

Under this Project the ABHIVRUDDI Society could able to take up 190 Sanitary Units in the Villages of Gubbi Taluka in Tumkur District. During the implementation of this Project the rural Community are educated on usage of sanitary units & preventing of various diseases that may cause.

The Society has mobilized finance from this agency in order to support & motivate the rural women's in construction of Sanitary Units. The ABHIVRUDI Society has supported Rs.9, 50,000/- for construction of 190 units.

INTEGRATED WATERSHED MANAGEMENT PROJECT (IWMP) – IGA SPECIALIST NGO, CHIKKAMAGALORE DISTRICT:

The ABHIVRUDDI has provided Specialist NGO (SNGO) services for the IWMP Watershed Project implemented by the Government of Karnataka, in Chhikkamagalore district. The Project was implemented in five sub watersheds of Chhikkamagalore district. ABHIVRUDDI organization had partnered with this project right from its first phase. It has provided services as the Specialist Non-Governmental Organization (SNGO) for the Income Generation Activities (IGA) and Micro Enterprises (ME) component of the IWMP project. Under the project, Abhivruddi had imparted different training and capacity building programme
